

# Celebrate *RiverFest*

*First Sunday in June • Donohue Park • Cornwall-on-Hudson • New York*

Dear Vendor,

Cornwall-on-Hudson will be celebrating its 22<sup>nd</sup> annual *RiverFest* on Sunday, June 2, 2019, at Donahue Park on the shores of the majestic Hudson River. To avoid competing with the Newburgh Illuminated festival again, we've moved *RiverFest* from the first Saturday in June to the first Sunday in June. As a result, vendors have the opportunity to participate in both events. *RiverFest* 2019 will feature a full day of entertainment, children's activities, and a large craft and food fair. The festivities will begin at 11:00 am and conclude by 6:00 pm.

You are invited to be a part of the *RiverFest* celebration. Food and craft vending spaces are available at a cost of \$85.00 per 10' x 10' area for applications received prior to May 1. The fee for applications received after May 1 will be \$100.00. If you require a larger space, additional fees will apply. The fee for Not-for-profit vendors planning to sell merchandise is \$25.00. Not-for-profit vendors are prohibited from offering food and beverages. Not-for-profit informational vendors are invited to participate at no charge.

Only food vendors and children's activity vendors must provide a certificate of insurance for June 2, 2019, naming the Village of Cornwall-on-Hudson, and Cornwall-on-Hudson RiverFest, Inc., as holders and additional insureds. Please include a copy with your application. In addition, the Orange County Health Department requires that all commercial food vendors submit to an inspection and pay a fee for a temporary, off premise food permit. We suggest that you make these arrangements in advance, directly with the Health Department to avoid any additional fees levied by the inspector on site. We will accept a maximum of 2 food vendors offering the same menu items. Decisions regarding vendor participation will be at the discretion of the *RiverFest* Committee.

*RiverFest* will be held on Sunday June 2, 2019, **rain or shine. There is no rain date scheduled and there will be no refunds issued.** Vendors should plan to provide their own tents, tables, etc. Food vendors will be located on an asphalt surface. Craft and other vendors will be located on the grassy area.

If you require electricity, you must supply your own generator and notify the committee in advance.

Please plan to arrive by 9:00 am. Set up must be completed no later than 10:30 am so that all vehicles can be moved to designated, on-site vendor parking areas. Transportation from your parking space to the festival site will be available. Shuttle buses will be available throughout the festival hours to transport visitors to and from the festival. The festival will end at 6:00 pm. All vendors are expected to depart no later than 7:00 pm.

A vendor application should be completed in full and returned by April 15, 2019, as spaces are limited. In the event an application and/or registration fee is received after all spaces have been assigned, the application and fee will be returned to you. Confirmation will be provided regarding parking, space location and set up information once your application has been accepted. Please check [www.river-fest.com](http://www.river-fest.com) for updates. Remember that all committee members are volunteers. Messages left on our voicemail will be returned as soon as is practical.
